YORK COLLEGE RULES AND REGULATIONS REGARDING RALLIES, DEMONSTRATIONS AND PUBLIC ASSEMBLIES

I. STATEMENT OF PRINCIPLES

York College respects the right of all members of the academic community to explore and to discuss questions which interest them, to express opinions publicly and privately, and to join together to demonstrate their concern by orderly means. York College ("the College") seeks to protect the right of voluntary assembly, to make its facilities available for peaceful assembly, to welcome guest speakers, and to protect the exercise of these rights from disruption or interference.

York College also respects the right of each member of the academic community to be free from coercion and harassment. It recognizes that academic freedom is no less dependent on ordered liberty than any other freedom, and it understands that the harassment of others is especially reprehensible in a community of scholars. Therefore, York College will not allow disruptive or disorderly conduct on its premises to interrupt its usual operation.

II. LOCATION

Specific locations on campus for rallies, demonstrations, and/or public assemblies have not been designated in an effort to provide the greatest flexibility for the organizers of such activities. However, the following parameters may impact the choice of an appropriate location in order to have the activity comply with the policies described herein.

III. REASONABLE TIME, PLACE AND MANNER GUIDELINES

The rights of assembly, free speech, and expression do not include unlawful activity or activity that endangers the safety of the campus community or the threat of damage to the College facilities and/or property. In addition, these rights do not permit the disruption of the normal operations of the College.

Campus rallies, demonstrations, and/or public assemblies shall adhere to the following parameters:

- The activity must be lawful, and may not violate or conflict with University or College policies or local, state, or federal laws.
- The activity may not unduly disrupt the educational purposes of the College.
- The activity may not unduly disrupt traffic, either pedestrian or vehicular. The right of way on streets and sidewalks must be maintained. No blocking or otherwise interfering with the ability of others to go in and out of campus buildings will be permitted.
- The activity may not jeopardize public or individual safety.
- The activity may not prevent, unduly obstruct, or interfere with the regular academic and institutional activities, or other approved activities of the College.
- There shall be no demonstrations during Final Exams or Final Exams reading period.
- The activity may not include expression that is obscene, defamatory, or consists of fighting
 words, threats of physical harm, or incites imminent lawless action, to the extent not entitled to
 protection as expression.
- Demonstrations are not permitted between 6 p.m. and 8 a.m. and should not exceed three hours in duration.
- No demonstrations are allowed inside College buildings.

- No structures are allowed on College property without the express written approval of the Vice President of Student Affairs and Enrollment Management or their designee. "Structures" include outdoor structures, tables, monitors, tents, and/or encampments.
- No volume of noise that prevents members of the College community from performing their normal campus activities is permitted.
- No unattended placards, banners, or other signs are permitted without prior approval.

IV. PROTOCOL

- 1. The President designates the Vice President of Student Affairs and Enrollment Management to be in charge of demonstration protocol.
- 2. Organizers of demonstrations should first consult with the Vice President of Student Affairs and Enrollment Management or their designee to coordinate time, place and manner of the demonstration.
- 3. The Vice President of Student Affairs and Enrollment Management will consult with the campus Director of Public Safety.
- 4. Peaceful, non-obstructive demonstrations will not be interrupted, blocked or provoked, and efforts should be made to conduct business as usual.
- 5. Non-peaceful and/or obstructive demonstrations shall result in demonstrators being asked to leave.

Persons in violation of these rules may be subject to disciplinary action, including expulsion or separation, in accord with University policy. Individuals may also be referred to law enforcement for consideration of criminal proceedings where appropriate.
